**Primary Accountability** - Responsible for mechanical and electrical repair and maintenance on wastewater treatment plants, pump stations, commercial/domestic water systems, collection systems and related equipment.

# Description of Primary Responsibilities

- 1) Responsible for the troubleshooting, maintenance and repair of plant and pump station equipment and operational systems, as well as collection systems and equipment:
  - a) Troubleshoots and repairs inoperable or malfunctioning equipment,
  - b) Tests emergency generators and stand-by equipment,
  - c) Reads and calibrates meters, sensors, gauges, etc.,
  - d) Performs infra-red temperature testing,
  - e) Checks pump and motor alignments,
  - f) Completes work order forms at completion of a call-out and submits to lead/manager on a timely basis,
  - q) Serves as the primary troubleshooter and repair person on major projects,
  - h) Services and performs minor repairs to vehicles, machinery, pump trucks and boom trucks,
  - i) Performs vehicle inspections and maintains vehicle logs per DOT Regulations,
- 2) Responsible for the efficient electrical and mechanical operations of water and wastewater facilities:
  - a) Conducts inspections on plant and pump station mechanical equipment,
  - b) Lubricates equipment, changes oil and filters, and makes running repairs and adjustments to machinery and equipment,
  - c) Participates in the installation, overhaul and repair of treatment and pumping plant equipment,
  - d) Performs meter readings as required,
- 3) Serves as an advisor to other staff members on electrical and mechanical issues:
  - a) Assists with the maintenance of equipment repair/replacement,
  - b) Provides telephone response to treatment and collection systems operators for troubleshooting prior to onsite response.
  - c) Responds to after-hours emergencies related to mechanical/electrical problems,

- 2) Possesses basic knowledge of practices and procedures used in the operation and maintenance of water and wastewater treatment and pumping plant equipment.
- 3) Possesses knowledge of servicing requirements of moving machinery, electrical pumping units and auxiliary equipment.

#### **Technical Skills:**

- 1) Has the ability to use basic mechanic hand and power tools, interpret meters and gauges, read basic blueprints and electrical schematics, and pipe fitting and plumbing principles.
- 2) Possesses ability to maintain, repair and service wastewater treatment plant, pump station and commercial/residential waste collection equipment and machinery.
- 3) Possesses ability to maintain and repair electrical equipment (except high voltage), including fuses, switches, panels and other electrical devices.
- 4) Is able to prepare basic correspondence and simple reports in Microsoft Word and Excel.

#### **Licenses & Certifications:**

- 1) Possesses a valid Hawaii Driver's License with CDL-B, tanker endorsement, air brakes, and no restrictions.
- 2) Possesses a valid State of Hawaii Department of Transportation medical examination certificate.

#### **Communications Skills:**

- 1) Exercises tact and diplomacy in the resolution of mild conflicts or disagreements.
- 2) Effectively communicates complex and/or technical information to co-workers and others.
- 3) Effectively communicates information in written (including electronic) correspondence.
